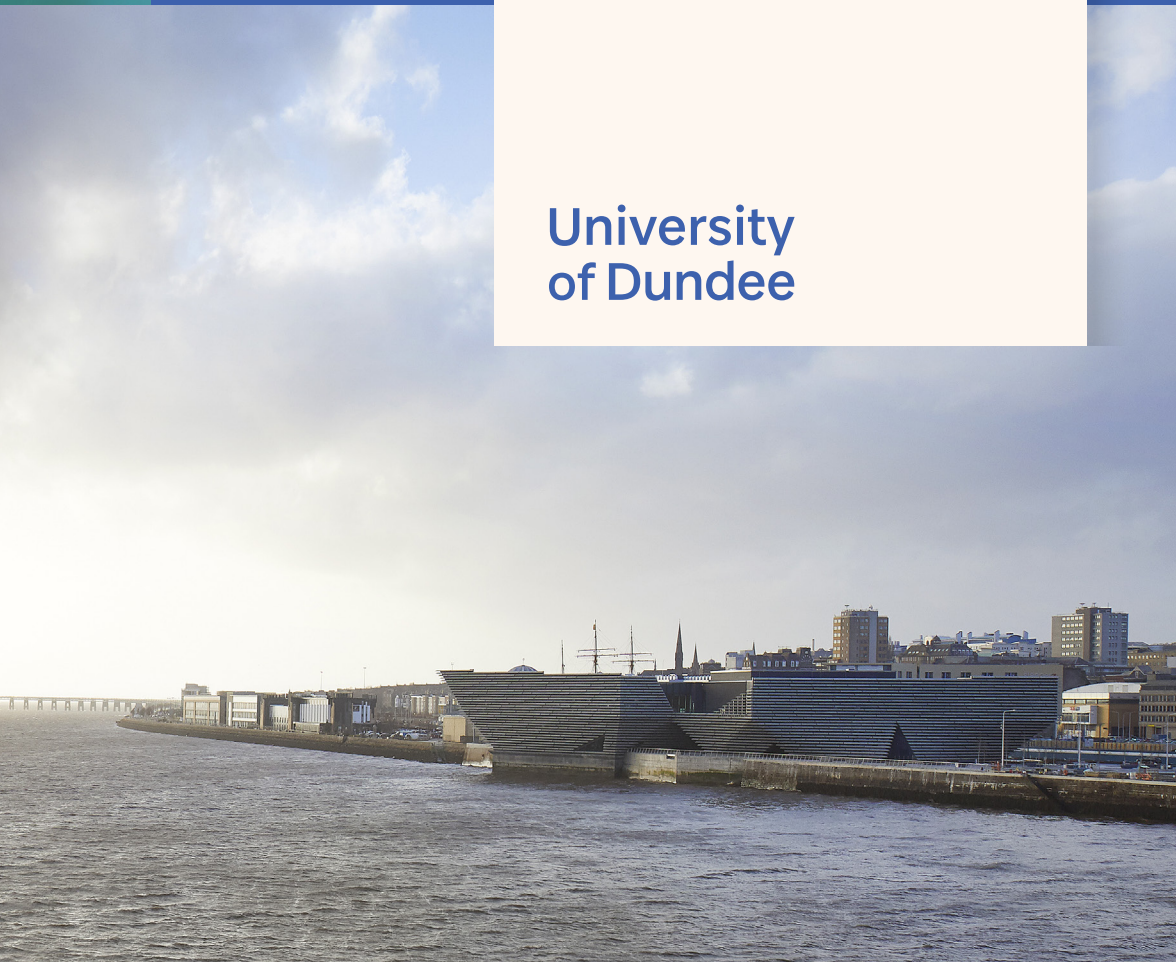

Good news stories

Leading strategic change in the NHS in Scotland: challenges and opportunities

The School of Business hosted a highly successful event on 23 March 2023, bringing together three of the most senior leaders in NHS Scotland to speak to an audience of around 120 people from healthcare, business and the University. The event also celebrated the honorary professorial appointments of Grant Archibald, Chief Executive of NHS Tayside, John Brown, CBE, Chair of NHS Greater Glasgow and Clyde, and Karen Reid, Chief Executive for NHS Education for Scotland (NES) to the School of Business. It took the form of a ninety-minute question-and-answer session with the three Professors of Practice, who forensically analysed the prospects for transformational strategic change in the NHS in Scotland, one of the most important policy challenges facing Scottish society. The evening was chaired by Professor Graeme Martin, of the Business School and former Vice Chair of NHS Tayside. Dr Jim McGeorge, Chief Operating Officer of UoD introduced the session and panellists, and Professor Morris Altman, Dean of the School of Business provided concluding comments.

In response to a series of questions from the Chair, Professors Archibald, Brown, and Reid gave highly reflective, honest, and penetrating accounts of the key strategic issues facing the largest and arguably most complex organisation in Scotland. Between them, these three leaders are responsible for over half of Scotland's 150,000 healthcare workforce, which gives them substantial warrant to speak on this topic. Their analysis began with an examination of the ever-increasing and changing demands for health and social care, including complex comorbidity among the elderly, the balance between health prevention and cure, health and social care integration and the endemic problems of health inequalities in Scotland. The panellists then turned their attention to the supply side, focusing on the problems of planning, recruiting, engaging, and retaining a professional workforce that can take up to a dozen or more years to train to full competence. The panel also reflected on possible changes needed in 'business models', structures,

and cultures if the NHS in Scotland was to transform itself. These included reflections on the obligations of the NHS, nationally and regionally, to act as an 'anchor institution' in the economy because of its great economic and social impact. Finally, the panellists provided key insights into the implications of these changes for clinical and non-clinical leadership development, especially in a context in which innovation and 'intrapreneurship' must be constantly balanced against priorities on patient safety and risk management.

The immediate feedback from the audience at the end of the event, and subsequent emails and texts sent to the organisers and panellists, provided a perfect testament to the individual and collective excellence of the three honorary Professors of Practice, who concluded by provided advice to university staff on addressing these grand challenges. As one highly experienced and senior member of the audience wrote:

"What a successful evening last night was... and the best use of my time. I'm as sure as I can be that you'll get responses which share my gratitude for allowing this event to take place...!"

He was spot on in his prophecy!

E-scooters as cultural object and lived experience: a socio-cultural perspective on e-scooter trials in the UK

Thomas Anker is currently working on an impact case with RollSafe in connection with the UK e-scooter trials. Across several cities in the UK, rental e-scooters have been trialled in order to collect evidence on the risks and benefits of potentially legalising this form of micromobility.

RollSafe has developed the UK's first e-scooter training programme and the University of Dundee School of Business has supported the continued development of the programme through insights from participant interviews. Two research assistants recruited among our business school students carried out interviews with participants in London.

As the analysis of the qualitative data progressed, the team realised that e-scooters are more than a particular form of transportation: it is a cultural object imbued with symbolic meaning. Frequently, research participants referred to negative stereotyping of e-scooter riders, particularly among male users from ethnic minorities. This is an interesting finding in and of itself, but especially significant because different user groups are using e-scooters for different purposes. Whereas most users are riding e-scooters only a few times just for the fun of it, a sub-segment is relying on e-scooters as their primary means of transportation to education, work and other daily activities. Especially young men from low-income, ethnic-minority households are likely to use e-scooters as a primary means of transportation.

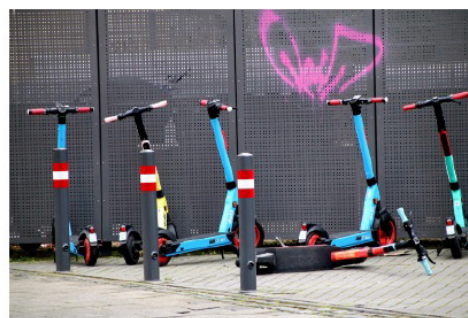
This is an important finding because it changes the way in which we should evaluate the relative risk of e-scooters. If e-scooters are seen as an occasional joy-ride, then our tolerance of risk should be very low. However, if this is a form of mobility that empowers a significant social group to travel independently to and from essential daily activities, our evaluation of risk should be different as there is much more at stake. It is no longer just about fun and entertainment, but about giving meaningful agency to people.

In this way, the project gradually changed focus to an exploration and critical reflection of the cultural perception of risk. The project has received funding from the Foundation for Integrated Transport and has also benefitted from generous support from the business school's Strategic Development and Impact Fund.

The findings are presented and discussed in the white paper "E-scooters as cultural object and lived experience: A socio-cultural perspective on e-scooter trials in the UK."

What a good employment experience looks like – past, present, and future

Graeme Martin, Stephanie Schreven, and Norin Arshed completed a large-scale, qualitative research study funded by NHS Tayside on “What a Good Employment Experience Looks Like – Past, Present, and Future”. The findings from the study were written up in a 60-plus page research report, sense-checked with four groups of over a 100 nurse leaders, presented to the NHS Tayside Board on two occasions and to its Area Clinical Forum, all during the first half of 2023. The work of the research team is being used as the evidence base to produce a new people, culture, and leadership strategy at NHS Tayside, as documented in Board minutes and testimonials from the Workforce Director and NHS Tayside Board.

This qualitative approach to understanding what employees value and experience about their work – past, present, and future – is seen by the Workforce Directorate as providing an in-depth complement to their employee surveys and is to be extended through longitudinal research over the next year. Kaushalya Herath has recently been appointed a post-doctoral research fellow in the School to work alongside the research team to undertake this extended study. The methodology and the insights provided by qualitative research of this nature is interesting NHS Education for Scotland and two large mental health trusts in NHS England, all of whom which have expressed an interest in undertaking similar work.

Institute for Social Sciences Research Global Scholar visit

In May and June 2023, Prof Alfonso Miranda of CIDE (Centro de Investigación y Docencia Económicas A.C), Mexico, visited University of Dundee for six weeks, under the prestigious Institute for Social Sciences Research Global Scholar Programme. His visit has been very productive, as evidenced by a Master Class on Survey Sample Design to PhD students, a research seminar to all ISSR members, and a joint British Academy grant application with Prof Yu Zhu of UDSB and Prof Alissa Melinger of School of Humanities, Social Sciences and Law. Moreover, Alfonso has been appointed as an Honorary Fellow by the UDSB for three years from September 2023.

Funeral poverty – Carlo Morelli

Dr Carlo Morelli has been appointed as a Trustee to the Board of Funeral Link Dundee. It is the social enterprise established by the Scottish Government and Dundee City Council to help support families with the cost of funerals in the city.

Professor Shamima Haque’s publication (together with the co-authors) entitled “Moral versus pragmatic legitimacy and corporate anti-bribery disclosure: evidence from Australia” has won the ‘Highly Commended Paper’ award for 2022 from the journal Accounting Forum (ABS 3*).

Senior hospital doctors' intentions to retire in NHS Scotland

An extensive survey and qualitative study, undertaken by Graeme Martin and former UDSB colleagues, Stacey Bushfield and Harry Staines, on "Senior Hospital Doctors' Intentions to Retire in NHS Scotland", was published on the 26 April 2023. The joint funders of the research – the NHS Employers in Scotland, BMA (Scotland) Consultants Committee, and the Academy of Medical Royal Colleges in Scotland – publicly stated a commitment to accept the findings and mandate all health boards in Scotland to take action to mitigate the premature exit of senior doctors from NHS Scotland. The report attracted significant media attention from the national Scottish press, radio and TV media, and the work of the School in this regard was cited in a Scottish Parliament select committee as evidence of a major problem facing the health service. Further research into the issues raised in the report, especially the implications for younger doctors experience of work and recruitment is underway.

Graeme's report titled "Senior hospital doctors' intention to retire in NHS Scotland" was published on several websites yesterday including BMA Scotland the University of Dundee (dundee.ac.uk/corporate-information/senior-hospital-doctors-intentions-retire).

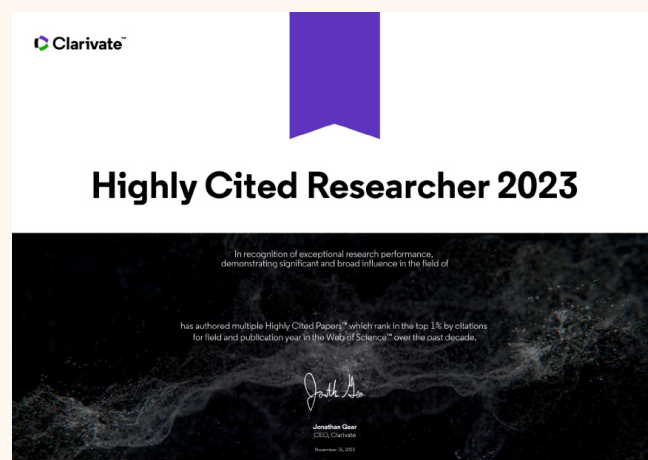

Funding news

- The School of Business participated in a successful application to the Wellcome Trust for institutional funding to “Progress a Positive and Inclusive Research Culture”. Graeme Martin is a co-applicant, alongside colleagues in Life Sciences, Medicine, Science and Engineering, and Humanities, Social Sciences and Law, and will lead/co-lead on the ‘Breaking Barriers for Leadership Transition’ and the Evaluation stages. The award is for £982,724 over a two-year period and is notable for involving the School of Business in genuine interdisciplinary research with some of the University’s key research-intensive schools.
- Dr Lee Roberts and Dr Yang Wang have been successful in securing funding from the PRME UK & Ireland Seed Funding Awards 2023. The proposed project seeks to examine the impact of the relationship between the vice chancellors (VCs) career horizon on the UK higher education institutions (HEIs) sustainability ranking? VCs are instrumental in steering the university for future sustainable development in challenging circumstances. UK HEIs face increasing pressures to address sustainability challenges and to perform well against other global HEIs. In the proposed project, we aim to examine the VCs personal attributes of tenure, gender, and educational background in relation to the UK HEIs sustainability ranking
- Professor Paul Allanson was part of a University of Dundee team that were successful in securing a £171, 432 ESRC Data Infrastructure research grant to develop a set of evidence-based recommendations to update ESRC’s research data policy in the light of changes to both the legal and data landscape since it was first formulated in 2014. The interdisciplinary team is led by Prof Angela Daly from the Leverhulme Centre for Forensic Science (LRCFS)/Law, also comprises Dr Alistair Geddes (Human Geography), Mrs Maeve Malone (Law) and Professor Niamh Nic Daeid (LRCFS) and with support from PDRA Dr Lucille Tetley-Brown and Awais Elahi. The multi-phase study will adopt a mixed methods approach consisting of a robust review of the current ESRC research data policy and legal landscape and a consultation exercise involving a survey and focus groups/interviews with a range of stakeholders involved in the use, deposit and management of research data. Best practice in social science research data policies from international examples will also be identified to inform our work, so as to produce an updated ESRC data policy that is fit-for-purpose, easily implementable and future-proofed. The recommendations for an updated policy will be in line with the highest legal, ethical and best practice standards in the UK and internationally, and cohere with wider UKRI data policies and those of other relevant organisations in the UK and internationally. Finally, we will suggest reasonable and feasible resources needed to implement the updated policy in practice.

The paper investigates how the provisions of the 2018 Corporate Governance Code influence the monitoring and reporting of corporate culture within FTSE 100 firms.
